

**WALTER S. MANGOLD AWARD**  
**NEHA AWARD**

**PURPOSE:** To recognize and honor a member of NEHA who has contributed significantly to the professional status of environmental health specialists. This is NEHA's highest honor and is only bestowed upon truly exceptional individuals.

**ELIGIBILITY:** To be eligible, the nominee must:

- Be a member in good standing of CEHA and NEHA.
- Be actively engaged in the field of environmental health.
- Have performed professional duties in the field of environmental health above and beyond the usual employment requirements so as to elevate the professional status of environmental health specialists.
- Exemplify the characteristics and principles for which Walter S. Mangold stood.
- Not be an incumbent of a NEHA office.

**NOMINATION PROCEDURE:**

1. Nominations for this award shall be made through CEHA. Nomination packages must be submitted to the CEHA Awards Committee, postmarked or electronically submitted no later than **March 4, 2022**.

**SUGGESTED FORMAT FOR THE NOMINATION PACKAGE:**

1. **General:** A letter from the affiliate CEHA Chapter President that makes the formal nomination; photograph of the nominee; and description of personal facts regarding the nominee.
2. **Education:** List of formal education as well as special training and experience.
3. **Employment History:** Record of places of employment, including scope of responsibilities.
4. **Professional Association Activities:** Organizational affiliations including NEHA, detailing offices held and committee responsibilities.
5. Contributions to the betterment of practice of environmental health science including publications authored or co-authored by the candidate, significant scientific or applied research, and accomplishments in the development or implementation of new, broader or improved concepts, procedures or techniques in the practice of environmental health.
6. **Other:** Significant contributions to the professional status of environmental health specialist not covered in the categories above.
7. **Summary:** Succinct description of why the candidate's contributions have prompted the nomination.
8. **Appendix:** Letter of reference or endorsement, copies of publications and other significant support documents.
